**ELECTION OF ELECTION BOARD**

Election of the Election Board of Local Union 3 shall take place on **Thursday, January 5, 2023, at the Joint Industry Board Auditorium, 65-35 Parsons Boulevard, Flushing, NY at 5:00 P.M.** No candidate for office shall be eligible to serve on this Board. No member shall be eligible for office unless they have been a member of Local Union 3 in continuous good standing for at least two (2) years, immediately prior to nomination. A judge and twelve (12) tellers shall be elected to serve as the Election Board.

**ELECTION OF LOCAL UNION 3 OFFICERS**

General Election of Local Union 3 Officers shall take place on **Saturday, May 13, 2023, at The Jacobs K. Javits Convention Center, Hall 1D, located on West 35<sup>th</sup> street and 11<sup>th</sup> Ave, New York City, New York, from 6:00 A.M. to 4:00 P.M.** No member shall be eligible for office unless they have been a member of Local Union 3 in continuous good standing for at least two (2) years, immediately prior to nomination. Officers' positions shall be Business Manager, President, Vice-President, Recording Secretary, Financial Secretary, Treasurer, five (5) Executive Board positions and Three (3) Examining Board positions.
